





Q2 - What is your current class standing?








Q5 - What term best describes your sexual orientation?




Q23 - What was the sex of the individual(s)? (select all that apply)



Q27 - Did you use the school's formal procedures to report the incident(s)?






Q34 - Since the beginning of the current school year (fall 2020), have you observed a situation that you believed was, or could have led to, a sexual assault?
